The official registration and financial information of Save A Shepherd Rescue Alliance may be obtained from the Pennsylvania Department of State by calling toll free, within Pennsylvania, 1 (800) 732-0999. Registration does not imply endorsement.

To surrender your German Shepherd Dog to Save A Shepherd Rescue Alliance (SASRA) you must complete and return this form along with a **\$50.00 Surrender Fee** to the address shown below. (Checks may be made payable to SASRA). We will then contact you to schedule an evaluation of your dog by one of our volunteers; you may be asked to bring your dog to the volunteer for evaluation.

Prior to evaluation:

- We must receive your completed Surrender Form and all applicable fees.
- Your dog must be current on ALL vaccinations (Rabies, DAPP); be tested for and on heartworm preventative and have received a Bordatella inoculation. You will be required to show written proof of the vaccinations and to provide copies of all veterinary records.

If your German shepherd Dog is accepted by SASRA for placement, your check will be deposited and you will be contacted to schedule a time for surrender to a SASRA volunteer. If your dog is not accepted into SASRA's program, your check will be returned to you or you may indicate that you wish for SASRA to keep the check as a donation in support of our work.

Pennsylvania state law requires that dogs be sterilized before being placed in a new home by a rescue organization. It is the policy of Save A Shepherd Rescue Alliance that dogs be FULLY VACCINATED prior to evaluation and spayed or neutered prior to acceptance into our program. If a spay or neuter is not possible due to age, time constraints, or the physical health of the dog, an **additional \$50.00 fee is required**. (Total Surrender fee for an intact dog is \$100.00).

If your dog is accepted for placement by SASRA we encourage you to send any leashes, collars, bowls, toys, blankets, crate, etc and a supply of current food. SASRA's volunteers try to find a good home for each specific dog and we ask that you complete this form as honestly as possible. Please do not leave out information in order to get your dog a home – it places both the dog and the prospective adopting family at risk.
